REPORT of the MINISTER of WORSHIP and CONGREGATIONAL OUTREACH

2020 - Year of the "Pivot"

January began normally; no hint of how a pandemic would impact 2020.

Church School in January led by Tom Kozak and Tracey LeGrand. Youth ministry monthly gatherings – "Couch Church" – began and the Confirmation Class almost completed their work to discern whether to join the church officially.

For a few months in Spring 2020, the Youth of St. Andrew's would meet on alternating weeks on Zoom while on the other week Church School children and their families would connect. We discovered that this format presented some challenges and was discontinued.

A formal visioning process to restructure our Christian Education ministry was organized, with leadership from Chris Pullenayegem and the Rev. Melody Duncanson-Hales from Regional Council and our Denominational body, respectively. Part 2 delayed until we can safely, physically meet.

With a group of "new members" we began planning a study of United Church of Canada theological perspective on a range of challenging topical issues – first one will be Medical Assistance in Death (M.A.I.D.) when we are able to meet in person.

With the St. Andrew's Place Board, I am continuing collaborative efforts with local non-profit reThink Green, to explore ways to make St. Andrew's more Creation friendly.

For Worship planners, "pivot" became the refrain, as in, we pivoted many times in 2020 – instantaneously from worshipping in the sanctuary to worship recorded from our homes and posted online. My focus was as follows:

- In March Subscribed to Zoom, worship leaders recording from home to be posted on the shiny new St. Andrew's YouTube channel.
 All worship online, to keep our community safe.
- In June a minimal team of worship leaders and sound booth volunteers began recording worship in the sanctuary for posting online.
- In August planning (safety protocols and procedures) for the possibility of inviting a small number of worshippers into the sanctuary in September, and developing a communications plan.
- In Fall of 2020 we began worship in the Sanctuary, carefully adhering to health protocols. We baptized two children and conducted 2 celebrations of life using carefully developed health protocols.
- Advent (December 2020) We began live streaming worship while still having only a small number of well-distanced congregants worshipping in the sanctuary.
- Christmas Eve to ensure the safety and health of the community we opted to record this special worship for posting on YouTube

A Stewardship Program was planned for Fall 2020, shortened because many/most of our community participated online. Thankfully, over 30 people returned their Response cards indicating their commitments for 2021.

Council – As with worship and most other aspects of life, there were several times of "pivoting". We thankfully welcomed Ralph McIntosh to as co-chair of Council with Phil Thurston. I offered support to these adaptive leaders as we:

- Moved to Zoom as our medium for all Council meetings beginning in March;
- Created an Emergency Planning Team with representation from St. Andrew's Place Board and Church Council, to regularly guide Council how to most safely do the many ministries here in pandemic times;
- Registered with "Canada Helps" so we could accept offerings made via the internet.
- Thanks to Ralph for his leadership in developing a comprehensive set of protocols and procedures for planned Fall worship – whether with a small congregation gathered, or just a minimal number of worship leaders recording worship to post on YouTube.
- Thanks to the Ministry & Personnel Team for developing comprehensive policies for working in the church office during these ever-changing pandemic times.

Our vision for 2021 is to continue to faithfully, and hopefully, do ministry in these challenging times.

- We hope to soon live stream every worship, and to steadily improve the quality of the picture and sound, and generally the experience of worship for people joining online;
- To support our community and the downtown vulnerable community through our ministries;

• To see COVID as an opportunity to be innovative in how we share Christ's love in ways that heal, seek justice and, generally, connect us in these fragmenting times.

REPORT of the MINISTER of PASTORAL CARE and OUTREACH

Question: How does a Minister of Pastoral Care offer pastoral care amid a pandemic?

Answer:

I have visited in doorways and apartment lobbies, in gardens and on decks, in the park, on walks, and for a few memorable afternoons, even in the lake.

Hospital visits continued by following strict protocols.

During the summer and fall, I had limited access to retirement homes; I have not been able to visit our members who live in Long-Term Care facilities since March.

Memorial services were held in outdoor settings with limits set by the province.

Weddings took place outdoors and within the sanctuary, as strict numbers of guests and protocols were maintained.

I have continued to connect by phone, email and sending cards.

In times of crisis, I have entered homes, and I try to maintain safe distance and wear a mask.

I participate in worship by offering the Prayers of the Community each week.

The Connex visitors helped all of us stay connected in 2020. Their care to this faith community has been a true blessing.

Knitters have worked hard at projects which extend the love of Christ to our community. Thank you for making prayer shawls, red scarves for Réseau Access Network, and loads of mittens.

The Prayer and Healing Group suspended their meetings in March, and we were delighted to resume for two months, in November and December. An average of six people joined in the weekly conversations.

Question: How does a Minister of Outreach do outreach amid a pandemic?

Answer:

You listen to the needs. You phone up the wise folks who are on the Reaching Out team and seek their wisdom. Together, we look for the gaps. Then we invite people to join us for the most incredible adventures. Working with our community partners and our

fellow travelers in the Downtown Churches group, you get to see how <u>God's kin-dom</u> takes on skin in our neighbourhood.

Short answer: We love our neighbour-no exceptions!

<u>Postscript:</u> I am grateful for having had this opportunity to dream, discern and work with you. Thank you for shining light and finding the most unexpected and amazing ways that keep your focus, not only on care for one another, but on finding ways to care for our neighbours. You are a church that makes pastoral care and mission the core of who you are as a community of faith. You are doing a good job!

MUSIC DIRECTOR REPORT

Beginning in September, I began familiarizing myself with the Disklavier and our organ and incorporated their capabilities as best as possible given our current COVID situation resulting in services being live-streamed and needing to have good sound quality to both attendees of the service and watchers from home.

Plans were set in motion to set up virtual choir pieces that would be incorporated into our live-streamed or pre-rerecorded services, but I was recently made aware that we currently lack the capability to imbed audio into our online presentations. I am in the process of setting up the software in the control booth that will allow us to have this capability, which will greatly enhance the quality of the overall presentation of St. Andrew's streams, which is a very exciting thing for the church as a whole! Each week Roger and I take notes on the recordings of the services to make future adjustments. We are always working to improve! New additions to the booth and setting up and becoming acclimated with the free-to-use Open Broadcast Software program will definitely be a game-changer!

I am currently in the process of finding a new piano tuner for St. Andrews. With Bob possibly moving out of the area soon it makes sense to try to find someone skilled and reliable in the area that the church can begin to build a relationship with.

CHRISTIAN EDUCATION REPORT

Church School began in 2020; profound thanks to Tom Kozak and Tracey LeGrand who were our teachers until the program was put on hold due to COVID-19.

Kate Barber began running Youth ministry "Couch Church" gatherings early in 2020, while Rev Dave and Kate led the Confirmation Class (not quite completed, we have one more session left which we feel should be done in person). In Fall of 2020, Kate opted to continue leading St Andrew's youth on a voluntary (rather than paid) capacity. Her leadership is very much appreciated.

We moved onto Zoom in spring of 2020 in order to follow health unit directives:

- the Youth of St Andrew's would meet to check in, play a fun game and to engage an issue.
- Alternating weeks on Zoom with the youth, the Church School children and their families would connect. Tom and Tracey took some leadership as did Gloria Kutorkor Appianing. We discovered that this format presented some challenges and was discontinued.

A formal visioning process to restructure our Christian Education ministry was organized, with leadership from Chris Pullenayegem and the Rev Melody Duncanson-Hales from Regional Council and our Denominational body respectively. Part 2 is delayed until we can safely, physically meet.

With a group of newer members to St Andrew's, Bev Chapman and Rev Dave began development of a study of the theology of The United Church of Canada as it understands a range of challenging topical issues. The first "issue" will be Medical Assistance in Death (M.A.I.D.) when the lockdown restrictions are lifted and we are able to meet once again in person.

CHURCH COUNCIL REPORT

To save a lot of repetition in this year's annual report, I need to state that COVID-19 changed a lot for St. Andrew's United Church. Unlike some organizations, your church council had to grapple with how we would meet the threat of disease on our members and on the residents of St. Andrew's Place. Therefore, the threat of COVID has made us busier than usual.

The Canadian Shield Regional Council mandated that we form an "Emergency Planning Committee" in order to plan what precautions would be followed to keep us safe. So, the entire council met as frequently as every two weeks from March onward to monitor COVID developments and to establish how we would continue worship. The increased number of meetings and the serious nature of their content took a toll on all members of council but especially upon Tracey Sanders-Ross our indefatigable secretary. The annual meeting of the Canadian Shield Regional Council was scheduled to take place in the late spring of 2020 with St. Andrew's as the host venue. The meeting is now scheduled to take place probably in November of 2021.

We used the "Zoom" software to conduct meetings and we saw worship progress from "Zoom" through to live streaming. In March, we began recording the services on Thursdays for posting on our YouTube channel, so that they could be viewed any time from Saturday onward. In June, we purchased a new videocamera to improve the video quality. This also enabled the Sunday services to be viewed live online during Sunday in-person worship, when we were able to gather in the sanctuary from October to December. The new laser projector purchased in February was finally installed in November, which has greatly enhanced the quality of the slide presentations. All this innovation in how we conducted both meetings and worship required technical innovation. We collectively owe a debt of gratitude to the major players on the technical front: Eric and Torrin Maag and Roger Pile. We also have a new recruit to the sound booth, Mallon Appianing.

We have been heartened by our financial results at year-end, thanks to renewed givings in the fall as we returned to worship as well as support from various government subsidies. However, our diminishing membership is still somewhat of a concern, in terms of both volunteers and financial resources. With this in mind, church council commissioned the Think Tank Team to engage the congregation in a series of online conversations related to addressing short-term challenges as well as our hopes and dreams for the long-term. Subsequent to receiving Rev. Catherine's request for a change in Pastoral relations as of March 31/21, this initiative has been transferred to a Discernment Team who will continue this work through to the March Annual meeting.

Without our usual worship in the sanctuary, we saw amazing efforts go into feeding the less fortunate even though we could not offer "Out of the Cold". We saw as many as several dozen of muffins prepared weekly and distributed (see the Reaching Out report).

The Downtown Churches Group is an informal grouping comprised of: St. Andrew's, Church of the Epiphany, Ste. Anne des Pins, Christ the King, All Nations Church and Trinity Evangelical Lutheran Church. The group is grappling with at least some of the downtown problems of homelessness and drugs by keeping us aware of our need to be closely involved.

In closing, a tricky year to manage.

Barb taught us so much about the importance of maintaining good relationships. For her love and witness, we are grateful. We remember Barbara with love.

REACHING OUT REPORT

The Reaching Out Team is committed to promoting the mission of St. Andrew's United Church in the downtown and beyond the bounds of our congregation. Several projects we anticipated sponsoring this year did not materialize but we are happy to report the following:

Matters of Interest

- Because of the arrangement that the United Church of Canada holds with the federal government, St. Andrew's was asked to hold funds raised by a community group sponsoring a refugee family. The funds will be dispersed to the Sudbury Welcomes Refugees when the family arrives.
- In partnership with MILC, the team offered a lively book discussion on March 8. Waub Rice, author of *Moon on the Crusted Snow* came to answer the questions and enquiries of 50 people who had read his very timely story of an Indigenous community caught in a natural disaster.
- Minutes for Right Relations were prepared and offered to the Worship team for the Sundays of Lent. Several of them were actually read before we shut down.
- Reaching Out and the Worship Planning Team have agreed to contact the Atikameksheng Anishinawbek community to highlight and learn more about our Manitou Collection painting by Stan Panamick.
- Members of Reaching Out have been involved with the City task forces around a safe injection site and food security during the pandemic.

Here are some of the things you did:

During the COVID days, through the extraordinary coordinating efforts of Rev. Catherine Somerville, members of the Reaching Out team found ways to alleviate the hardship of many who found themselves on the streets. Restaurants and the usual eating places were closed, bathrooms were unavailable, the opioid crisis was rampant. This work was supported by your givings to the Benevolent Fund

- The muffin mission over 40 people baked dozens of muffins every week, to be picked up and delivered to the Off the Street shelter and the Warming Centres on Frood Road and YMCA.
- **Healthy snacks** were provided to the Warming Centres and Off the Street Shelter.
- **Donation** of \$5000 to the Elgin Street Mission and \$2000 from Out of the Cold fund.
- Pizza delivered to Réseau Access Network every week from March until
 September, with granola bars, sandwiches and water. Special Mention
 Awards: Marcel Lapalme and Rhodine White, Jim and Joyce Dickson, Jane Baggs,
 Myfawny McIntosh, Jill Bennett who shopped, picked up and delivered under
 Catherine's direction.
- The Advent Bundles: During the four weeks of Advent, you made bundles with children's articles, socks, food items and toiletries. Even though many of you worshipped at home, you found ways to get your bundles to the church. Three carloads of bundle contents were delivered to our friends at Louis Street, Better Beginnings, Independent Living, Réseau Access Network
- Inner City Home: Your generosity was truly Loving your Neighbour IN ACTION. Special Mention Award to Brennan Maag for sorting and bundling, and delivering the bundles

Our Ongoing Project

Love Your Neighbour - a new initiative for St. Andrew's

The digital rights of a banner, seen on Facebook from All Saints Episcopal Church, Washington, DC, were purchased with the approval of Church Council. A large standup banner was procured and the theme of inclusion and welcoming was introduced to the community. The services of a consultant, Anna Barsanti, were sought to help us launch the message of the banner and during the summer months Catherine and Sylvia met with Anna to plan the launch an ongoing presentation of the message of the banner – Love your Neighbour, No Exceptions. You were invited to send in pictures for the Picture Pillars on the theme "Love looks like this..." Jill Bennett wrapped the pillars and made a cloth for the communion table in the colours of the banner. Some "swag" items were made available. We have a lively song to go with the banner. Conversation groups were offered in a way to help people grow their connections to one another. Our efforts will be renewed when we can meet again. This project is being supported by the Innovation Fund from Memorial Gifts. Special Mention Award to Tracey Sanders-Ross who procured the banner and swag for us and Jill Bennett for supporting with the décor.

The work of Reaching Out is enabled by Rev. Catherine Somerville whose energy and commitment to walk with others inspires and motivates us. During the grievous days of the pandemic, she found ways for us to make a difference and we are grateful for her vision and unending support for the work of this team. The word spread far and wide that St. Andrew's was helping hurting people, and many in our community and beyond our church family supported our initiatives.

Those are just some of the stories you shared in 2020.

COMMUNICATIONS TEAM REPORT

You would think that the Communications team was formed due to the COVID-19 pandemic impacting us in so many unforeseen ways. (I'm already breaking the guidelines around committee reports which are to avoid *preambles about how 2020 was an unusual year due to the pandemic* – although it really was!)

Actually, the Communications team was formed based on the recognition, in large part by Reverend Dave, that vibrant church operations in 2020 are interconnecting community and congregation through many novel technological means and platforms. The idea that we should focus some of our attention to support the Church in advancing and improving how we communicate resonated well with many of our members. Given its importance, it was one of the first topics of discussion during the Think Tank process.

There are two main lines of focus:

- 1. Internal Communications: how we share amongst the congregation activities, events, successes all the "goings-on"... Certainly in this regard, dramatic changes occurred quickly in March 2020 as to how services (and coffee hour!) were offered. The Communications team supported the Church by ensuring that all our traditional and non-traditional activities were as visible and accessible to all congregants as possible. In under a year, we have gone from services in the sanctuary with a PowerPoint presentation to a video recording and even live streaming of our services. We continue to look at ways to improve our digital product and presence on platforms such as our website, YouTube and facebook.
- 2. External Communications: how we share outwardly towards the greater community including the Place and our downtown neighbours. With digital technologies, the circle is constantly growing wider and wider. The Team was active in building out the "Love Your Neighbour" campaign and its related marketing materials.

Dave and myself, with occasional participation from Ralph, Roger and Torrin, has been meeting monthly to find ways to improve both our execution and the strategic direction of how St. Andrew's shares the faith in words and in deeds.

SHARING OUR RESOURCES REPORT

The Resources Committees are responsible for the temporal matters of the congregation. The Resource teams oversee: the annual budget and monthly financial statements; administrative and policy matters; Stewardship initiatives; Memorial Gift funds; Fundraising; and Property maintenance.

The Board of Trustees oversees all matters related to insurance and the church's investments.

Financial Oversight and Administration

What we do:

- Provide oversight of the operating budget and the Memorial Gifts Fund
- The Treasurer and Accountant administer the monthly operating revenues and expenditures, work with the auditor for the year-end financial statements, and prepare the Charity return
- The Memorial Gifts team administers the activities of the various other Memorial Funds
- The Finance team also reviews these activities monthly or when needed and develops new policies for Council's approval when required
- Members also draft the annual operating budget for the approval of Church Council and the congregation.

Stewardship

Stewardship is the wise use of time, talent and financial resources and helps guide the congregation to encompass a framework for living in the lifelong journey of what it means to be a Christian today, with a focus on being a downtown church.

What we do:

- The committee runs a comprehensive program over several weeks in the fall using materials adjusted to our specific needs that was developed by the United Church of Canada
- Testimonials were provided by members of our congregation and were very well received, from Diane Trollope, Sue Nykilchuk and Jen Bruneau, and Torrin Maag
- The program we used called "Loving our Neighbours" also supported the Reaching Out Team's new initiative.

Special thanks go to Rev. Dave, especially for his weekly sermon focus on what Stewardship means and how members of St Andrew's can incorporate it into a living testimony of what it means to be a Christian today.

We are a generous congregation, giving of our time, talents, and financial resources. We came close (even under extenuating circumstances) to meeting our 2020 financial goals in terms of member donations and loose offerings, as well as our Mission & Service target goal. We also received 33 pledge response cards – although we have fewer donors than last year, many members have increased their donations and volunteered countless hours to serving our mission.

Volunteering time and talent is key to the success of our church and the wider church Many opportunities exist to help – contact either of our caring and devoted ministers if you would like to become more involved.

Memorial Gifts

The Memorial Gifts Committee administers the Restricted and Unrestricted Memorial and Endowment Funds of St. Andrew's United Church. It receives applications for the Lola McNaughton Bursary and contributes in the selection process for the Rev. Dr. Earl and Elizabeth Lautenslager Scholarship at Huntington University. Normally the Committee holds a *Celebration of Gifts* service to honour those in whose memory donations have been received.

Highlights for 2020

- A complete review of all restricted funds and the criteria for use. Three funds have been revised to allow access to capital. The Maida Eliot fund for Christian Education has been exhausted.
- A new fund (\$5 000) was established from the estate of Dr. Walter Frank Cook, the interest of which will support pastoral care.

- The Lautenslager Scholarship was awarded to William McCormick.
- There were no applicants for the McNaughton Bursary.
- The *Celebration of Life* service was postponed; the Committee anticipates eventually holding an *in-memoriam* service that will represent two years.
- The Committee drafted a document on Charitable Bequests that will be brought to Council. Its intention is to raise awareness about donating to the mission of the Church through one's will.
- The Committee reviewed the United Church of Canada's Financial Handbook regarding the use of Memorial Gifts and initiated discussion on how our Church might develop policy.

This Committee oversees the procurement, maintenance, repair, replacement and disposal of church equipment and furniture. The Committee endeavours to make spaces inviting to all and has at least one member who sits on the St. Andrew's Place Board. Decision-making involves awareness of the Church-Place Lease Agreement; the Space Improvement Protocol; the Gift Acceptance Guideline; Restricted Funds; and the Council-approved process for managing surplus items.

- Maintained the Welcoming Area (planter & upper lobby) appropriate to each season

In addition to raising dollars, fundraising events provide an opportunity to meet new people, and reconnect with people you know. They are a time to laugh, to share and to work together. Unfortunately, due to Covid-19, we were unable to hold many of our annual FR events; however, we look forward to the time when we can gather once again.

Fun-D-Raising events 2020:

<u>Valentine's Spaghetti Dinner and Silent Auction</u>, February – A very successful event made possible by the tremendous support received from the congregation, our many volunteers and the many community partners who donated to the Silent Auction.

<u>Tea Connections</u>, November 29, 2020 – In early October, the family of the late Barbara Ritchie, a lifetime member of St. Andrew's, donated her collection of Cups and Saucers for our use. The FR committee met with Rev. Catherine and came up with a plan to use this gift through an event which would not only honour Barb but would be an extension of the care she so generously offered to the world. With that in mind, we put plans in place for a "Tea Connection!" with the proceeds to be used to fund a "Socks for Souls" project. We would use half the funds in 2020 and the remaining funds in 2021 to purchase socks to be distributed to those in need. With the support of our Church family, our many volunteers and our community partner, Giant Tiger, the event was successful beyond our expectations. We were able to distribute over 300 pair of socks and look forward to continuing Barb's legacy in 2021.

<u>Think Tank Session December 8, 2020</u> – On December 8th our committee participated in discussions to hear and share thoughts and new ideas for the FR committee to consider. The committee in turn, presented an outline of our 2021 plans. Unfortunately, a COVID-19 lockdown was called for and projects are back on hold until further notice.

Technology:

- New computers were installed in the main office and finance office in January 2020
- Since March, our worship services have been offered using three different platforms, depending on the public health restrictions in place at a given time:
 - pre-recorded using Zoom technology,
 - o pre-recorded live in the sanctuary,

- live streamed from the sanctuary on Sunday mornings (with congregation members present from October to December)
- The weekly Fellowship Time is also held on Zoom, as are the majority of the important meetings that support the work of the church
- The November 1st Annual Meeting was live streamed from the sanctuary, with 50 congregants present and another 30 attending on Zoom
- The costs of our new video camera (purchased in June) and laser projector (installed in November) have been shared by the Place
- The Technology and Communications teams are researching additional hardware and software purchases to improve the live streaming experience

BOARD OF TRUSTEES REPORT

St Andrew's Board of Trustees is responsible for investments and insurance matters.

Investments:

- Our church's funds are invested through RBC Dominion Securities and Canoe Financial through The United Church of Canada.
- We continue to be in compliance with the church's Investment Policy regarding the proportion of fixed income and equity investments.
- In 2020 St. Andrew's realized a gain of \$11,045 through funds held at Canoe, at a growth rate of 7.33%.
- RBC Dominion investments were reinvested in January and June.
- Our funds held at RBC Dominion Securities realized a gain of \$3,174.68 in 2020 (0.86%) through a combination of dividends, interest, and changes in market value.
- \$30,000 was held back from re-investment in January 2020 to offset the adjusted 2019 year-end deficit.
- \$35,000 was held back in June 2020 as a precaution against a potential cash shortfall, to safeguard against negative financial trends related to the COVID-19 pandemic.
- In late October, the church drew on \$15,000 to cover a shortfall at that time. Thus, our total draw on our investments in 2020 was \$45,000.

Insurance:

- We continue to purchase our contents insurance through the General Insurance Plan for The United Church of Canada; our provider is Hub International UCC Protect.
- In November, the Chair of Trustees worked with staff and members of the Property, Resources, Technology and Worship Teams to update the church's property inventory, in preparation for submitting updated documentation to our insurance provider.
- Our insurance policy was renewed December 1, 2020.

MINISTRY and PERSONNEL COMMITTEE REPORT

The Ministry and Personnel (M&P) Committee is a confidential, consultative body that acts under the guidelines of The United Church of Canada. Among other roles, we assist ministry personnel and lay staff in the performance of their duties.

The issue that affected staff most profoundly in 2020 was how to continue to provide compassionate Christian care not only to the St. Andrew's community of faith but beyond into the community during the COVID-19 pandemic.

This called for an extraordinary measure of creativity, flexibility and resiliency on the part of staff, and extraordinary support from volunteers to deliver worship services online beginning in March. For this and for the new ways staff and volunteers found to reach out as part of our mission as a downtown Sudbury church, M&P expresses its deep appreciation.

In April, Council accepted with much regret the resignation of Dr. Robert Hall, Director of Music. After 25 years of outstanding musical leadership and service to St. Andrew's, Bob elected to step down at the end of August.

In September, M&P welcomed new Music Director, Jonathan Swift, under a part-time 10-month contract. The committee sincerely thanks Jonathan for sharing his musical talents with St. Andrew's.

The committee regretted that, due to pandemic restrictions, the church was unable to renew contracts with our Church School and Youth leaders.

In 2020, M&P continued to work with the ministers to refine their ministerial partnership, conducted annual performance and job description reviews with staff, and developed COVID-19 workplace policies and procedures in consultation with staff and office volunteers for their health and safety, which included overseeing installation of

plexiglass shields in the church office. M&P members served on the ad hoc and search committees for a new Music Director, the Emergency Planning Committee and the Think Tank Team. In place of hosting a Christmas sit-down lunch for staff and office volunteers, we door-step delivered our thanks in the form of treat bags.

In the coming year in addition to attending to ongoing staff responsibilities, M&P is supporting the work of the Discernment Team. We will keep monitoring pandemic directives and work with staff to adjust workplace policies as needed. We hope to hold a staff team building exercise that we postponed due to the pandemic. We look forward to eventually welcoming back our dedicated office volunteers to serve in new ways, just as we too, will continue to adapt to provide resources and support for staff.

As Co-chairs, we express our gratitude to the committee, including our newest member, Wayne Wahamaa, for your commitment, compassion and careful consideration of all matters that come before us, and in particular to Bert Brankley, who stepped down as Chair at the end of August after many years of skilful leadership. We are blessed to be serving St. Andrew's with you.

BENEVOLENT FUND REPORT

Without you, none of these good works could have happened. Thank you for supporting the Benevolent Fund which provides emergency support to individuals and downtown neighbours. You were there for your neighbours in the most unusual year!

What we did:

- Provided weekly snacks to three warming centre locations Frood Road, The Samaritan Centre, The YMCA. (Thanks to shoppers Jim and Joyce Dickson!);
- Provided "Mr. Noodles" (like Cup a' Soup) to the Y's warming station. (Thanks to shopper Jane Baggs!);
- Food support, gift cards and groceries, responded to seven requests for help;
- Provided winter boots and school shoes to a child;
- Provided access to emergency counseling services for two individuals;
- Provided 23 pair of men's gloves to the Samaritan Centre's drop-in space;
- Supported the Elgin Street Mission when they reached out with a special appeal to community partners (to help with added expenses incurred as they provided take-out meals at the arena and at their location on Elgin Street). In total, \$5,000 has been donated to the Elgin Street Mission through the Benevolent Fund;
- Helped with travel expenses for a family who needed to access medical help;
- Provided weekly pizza, snacks, and water to the Réseau Access Network drop-in during the first pandemic shutdown;

- Provided snacks to Louis Street's after school homework club, (January to April).

The balance of the Benevolent Fund as of December 31, 2020 is \$17,194.25.

Disbursements in 2020 totaled \$11,546.60

Generous donations totaling \$14,038.80 were gratefully received.

INDEPENDENT AUDITOR'S REPORT

To the Members of St. Andrew's United Church

Report on the Audit of the Financial Statements

Opinion

We have audited the financial statements of **St. Andrew's United Church** (the Organization), which comprise the statement of financial position as at **December 31, 2020**, and the statements of operations and changes in net assets and cash flows for the year then ended, and notes to the financial statements, including a summary of significant accounting policies.

In our opinion, the accompanying financial statements present fairly, in all material respects, the financial position of the Organization as at **December 31, 2020**, and its financial performance and its cash flows for the year then ended in accordance with Canadian Accounting Standards for Not-for-Profit Organizations (ASNFPO).

Basis for Opinion

We conducted our audit in accordance with Canadian generally accepted auditing standards. Our responsibilities under those standards are further described in the Auditor's Responsibilities for the Audit of the Financial Statements section of our report. We are independent of the Organization in accordance with the ethical requirements that are relevant to our audit of the financial statements in Canada, and we have fulfilled our other ethical responsibilities in accordance with these requirements. We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our opinion.

Responsibilities of Management and Those Charged with Governance for the Financial Statements

Management is responsible for the preparation and fair presentation of these financial statements in accordance with ASNFPO, and for such internal control as management determines is necessary to enable the preparation of financial statements that are free from material misstatement, whether due to fraud or error.

In preparing the financial statements, management is responsible for assessing the Organization's ability to continue as a going concern, disclosing, as applicable, matters related to going concern and using the going concern basis of accounting unless management either intends to liquidate the Organization or to cease operations, or has no realistic alternative but to do so.

Those charged with governance are responsible for overseeing the Organization's financial reporting process.

Auditor's Responsibilities for the Audit of the Financial Statements

Our objectives are to obtain reasonable assurance about whether the financial statements as a whole are free from material misstatement, whether due to fraud or error, and to issue an auditor's report that includes our opinion. Reasonable assurance is a high level of assurance, but is not a guarantee that an audit conducted in accordance with Canadian generally accepted auditing standards will always detect a material misstatement when it exists. Misstatements can arise from fraud or error and are considered material if, individually or in the aggregate, they could reasonable be expected to influence the economic decisions of users taken on the basis of these financial statements. 1. ORGANIZATION

St. Andrew's United Church (The Church) is a religious and benevolent organization with its congregation in Sudbury, Ontario. It is unincorporated and is a registered charity under the Canadian Income Tax Act and is therefore not subject to either federal or provincial income taxes.

2. SIGNIFICANT ACCOUNTING POLICIES

(a) Basis of Accounting

These financial statements have been prepared in accordance with Canadian Accounting Standards for Not-for-Profit Organizations and includes the significant accounting principles set out below.

These financial statements have been prepared for statutory and internal reporting purposes.

(b) Fund Accounting

The Church follows the restricted fund method of accounting for contributions. As the Church receives funding for special as well as operational purposes, the financial statements are presented in a manner which segregates the following fund balances:

- (i) The general fund, which accounts for program delivery and administrative activities and represents the day-to-day operations of the Church; and,
- (ii) The investment fund, which represents those funds set aside by The Church for investment purposes. The expendability of these funds, which consist of internally restricted capital, externally restricted endowments, and internally restricted memorial gift funds are restricted to specific purposes as prescribed by the benefactors or, as set out at the discretion of The Church. Investment income earned on the resources of these funds are included in the investment fund income.

Interest earned on the Capital fund, the restricted Thornton fund, and the restricted Memorial Gifts fund has been authorized for annual transfer to the operating fund in order to offset specific expenses.

(c) Revenue Recognition

Donations and other contributions are recognized as revenue in the year of receipt. Investment income is comprised of interest, dividends, realized gains and losses on the sale of investment, and unrealized gains and losses in the fair market value of investments. Interest on guaranteed investment certificates is recognized over the term of these investments using the effective interest rate method.

2. SIGNIFICANT ACCOUNTING POLICIES (Cont'd)

(d) Financial Instruments

The Church initially measures its financial assets and financial liabilities at fair value and then subsequently measures all of its financial assets and liabilities at amortized cost except for investments in equity instruments that are traded in an active market, which are measured at fair value. Changes in fair value are recognized in the statement of operations in the period incurred.

(e) Capital Assets

The Church meets the criteria that allows for capital assets to be expensed in the period incurred. Capital assets are accounted for as an expense when acquired and charged to the committee or fund to which it relates. Any specific funding received related thereto is recorded as revenue of the fund.

(f) Contributed Services

Volunteers contribute hundreds of hours annually to assist The Church in carrying out its service delivery activities. Due to the difficulty of determining their fair value, contributed services are not recognized in these financial statements.

3. INVESTMENTS

Mutual funds consist of a combination of an investment savings account and an investment in a capital balanced fund. Guaranteed investment certificates have effective interest rates ranging from 1.20% to 3.03% and maturities of no longer than two years. For 2020, Canadian equities paid out dividends averaging 8.71% of their original cost of \$52,734.

For 2020, investment income of \$19,799 included dividend income of \$4,596, interest and other income of \$8,612, and \$6,591 of Fierra fund income distributions on the investments.

4. COMMITMENT (RELATED PARTY)

The Church is committed to the lease of its premises from The Place at an annual rental cost of \$16,800 for 2020 & 2021 (plus any applicable HST). The Church also rents additional facilities within the building on a fee for service, per occasion, basis.

5. OTHER AUTHORIZED TRANSFERS

During the year, one time expenditures were incurred which were partially financed by transfers from the Investment fund. The details are as follows:

All fund transfers were from the Memorial Gifts Fund.

6. FUND FINANCING TRANSFERS

As in past years and when required, The Church has provided for annual general fund deficits or surpluses through the use of funds allocated annually from the Memorial Gifts fund.

7. CAPITAL ASSETS

As noted in the significant accounting policies, The Church expenses capital asset purchases in the period incurred. There were no capital asset purchases expensed in 2020.

Major categories (or specific capital assets) owned and safeguarded by The Church include; the Casavant pipe organ, the sanctuary and chapel doors, various pieces of stained glass, the sound and lighting systems, pianos, oak chairs in the Church, chapel furniture and fixtures (including marble podium and altar) as well as various other fixtures, equipment, office furniture, art works and other accoutrements.

8. DEFERRED REVENUE

Deferred revenue represents receipts that specifically relate to expenses to be incurred in the period subsequent to the current fiscal year.

9. FINANCIAL INSTRUMENTS

(a) Fair values

The Church's financial instruments consist of cash, amounts receivable, investments, accounts payable and accrued liabilities.

Cash is reported at fair value in the statement of financial position. Amounts receivable, accounts payable and accrued liabilities are reported at amortized cost which approximates fair value due to their short-term nature.

Investments are reported at their fair market value.

(b) Risks arising from financial instruments

Credit Risk

The Church's cash and investments are all held at major financial institutions.

Interest Rate Risk

The guaranteed investment certificates that are held by the Church do not have maturity dates of greater than one year.

Market Risk

Market risk is the risk that the fair value of a financial instrument will fluctuate because of changes in market prices. The Canadian equity securities that are held by The Church would be subject to market risk.

It is Management's opinion that The Church is not exposed to significant credit, interest rate or market risk arising from these financial instruments.

10. RELATED PARTY TRANSACTIONS

(a) Relationship

St. Andrew's Place, Sudbury ("The Place") is a corporation, incorporated without share capital, whose Board of Directors is made up of a majority of members of St. Andrew's United Church.

10. RELATED PARTY TRANSACTIONS (Cont'd)

(b) Significant Transactions

These related party transactions were made at exchanged values.

During the year, The Church made lease payments (including parking) and ancillary rental payments to The Place in the amount of \$22,570 plus HST (2019 - \$30,468 plus HST).

During the year, The Place also made payments to The Church for miscellaneous piano rentals in the amount of \$500 (2019 - \$1,500).

(c) Due to Related Party

At year end, \$1,650 (2019 - \$3,404) of the above mentioned transactions was due to The Place from The Church.

11. ENDOWMENTS AND OTHER RESTRICTED FUNDS

Endowment funds are restricted for a variety of purposes including audio and visual, scholarships, bursaries, organ, pastoral care, capital, youth education, music, and student ministry.

Internally restricted net assets include the Capital fund and the Memorial Gifts fund. The Capital fund arose from the sale of the church manse. Church Council set aside these funds and only the interest is to be used to cover housing costs of the minister. The Memorial Gifts fund results from individuals making donations "in memory" of someone who has passed away. These funds are not restricted by the donors, but Church Council has restricted the use of both the actual funds and the interest for several purposes, including deficit financing.

Within the Memorial Gifts fund is a balance set aside as the Innovation fund. This is calculated as 5% of the uncommitted balance of the Memorial Gifts fund as of January 1 of that year.

12. OTHER INFORMATION

Certain prior year information has been restated to conform to the presentation adopted for the current year.
